

PUBLIC ACT 17-130 ANNUAL REPORT

On June 30, 2017, Public Act No. 17-130 ("Act"), was signed into law. The Act, now codified in Connecticut General Statutes §§ 10a-151f - 10a-151i, provides UConn and the Connecticut State University System with an effective means of making three types of purchases that are unique to higher education. The three types of purchases are: (1) those made outside the United States and used abroad; (2) those made as part of a collaboration agreement; and (3) those that do not involve the expenditure of state or certain institutional funds.

Conn. Gen. Stat. § 10a-151g authorizes UConn's Board of Trustees ("BOT") to adopt procurement policies for each of these three types of purchases. Once adopted, the procurement policies would apply in lieu of the procurement processes prescribed in Conn. Gen. Stat. § 151b(b).

It also requires UConn to submit an annual report to the legislature's Higher Education and Government Administration and Elections Committees, commencing on January 1, 2018. Under the Act, the annual report shall contain: "(1) any policies adopted pursuant to this provision (2) a description of any revisions or amendments made in the previous fiscal year to any previously adopted policies, and (3) a description of each contract entered into or amended in the previous fiscal year pursuant to such policies."

This is the fifth such annual report.

Executive Summary

In accordance with Conn. Gen. Stat. § 10a-151g, the University submits its annual report for the period of January 1, 2021 through December 31, 2022.

The University had issued a total of 24 contracts in support of its academic and research missions that were sourced through the Red Tape legislation. We did not issue any contracts supporting UConn Health activities for the calendar year of 2022.
